

## INTRODUCTION

This book has been written to document the migration of Scotsman William Thomson to America from Edinburgh, Scotland. This could be the story of any of those courageous Scottish Covenanters who dared to defy the corrupt powers who attempted to impose their evil wills upon Christian people. This story documents the spiritual impact of a family that yielded probably thousands of ministers who served in churches across a growing nation. They were a part of multiple denominations, beginning as Presbyterian and then becoming Primitive Baptists whose descendants later became Southern/Regular Baptists. Some were Methodist ministers.

Chapters 2, 3, and 4 are mostly historical accounts about Scotland, the Covenanters, and the Dutch maternal ancestors who settled Ulster County, New York. Most of these articles are paraphrased from various online historical web sites. Some information was taken from various Beall web sites in order to accurately indicate how Col. Ninian Beall transported these Scottish families to America and settled them in Charles County, Maryland. The account about the Dutch maternal ancestors begins with John Van Meteren and his wife Sarah DuBois Van Meteren. The couple were the parents of Rebecca Van Meteren who married Cornelius Eltinge. Yacomintye Eltinge, the daughter of Cornelius and Rebecca Van Meteren Eltinge, married John Thompson who was the son of migrating ancestor William Thomson. The Van Meteren family migrated from Kingston, Ulster County, New York to New Jersey and thence to Maryland where Cornelius Eltinge owned a grist mill at the outlet of Seneca Creek to the Potomac River. One interesting historical note is that General George S. Patton was descended from Eleanor Eltinge, Yacomintye's sister who married Isaac Hite. Her sister Sarah Eltinge was married to Isaac's brother John.

Migrating ancestor William Thomson was married to Ann Chittham, daughter of John Chittham. William and Ann Chittham Thompson's son John married Yacomintye Eltinge and their son William was named after his grandfather William Thomson. This grandson William Thompson married Susannah Fields and their son James Fields Thompson was the father of Elisha Thompson.

Ironically, the spiritual corruption that William Thomson left Scotland to escape has impregnated Washington, D.C., in exactly the place where he settled. The capital of this nation has now become a cancer that threatens to destroy the freedom of every American. And the nation's capital is a symbol of the decadence of a welfare state that was conceived in the mind of Satan himself and implemented through the efforts of his politician children. No bigger devils hath Hell than those who presume to be the guiding rulers of America. ## CHAPTER 1- THE COVENANTER'S QUEST DEFINED

Beginning with time spanning thousands of years B. C. there is a history of men who would subordinate others for their own purpose and benefit. That was done by the use of force, deception, superstition, and religion. These facts are part of history. When you examine the ancient civilizations of Egypt, you find that the Pharaohs represented themselves to be gods. They used force to rule and religion to justify that rule. They also used religion as a tool to maintain subordination.

The man who would be king had at his disposal others who wanted to reap the benefits of power. He had the military force of loyal servants who would kill, loot, or attack others at his will. He paid them through power or the spoils of their crimes. Then to keep the subordinates of the nation under control he told them that he was God and that if they fought against his rule they were fighting against God. In ancient times there was no means for mass communication. So the kings put out decrees or documents in writing that could be circulated to others. The regular method for communication to assembled groups was at worship services. So the king had the services of the priests at his disposal to address the masses with his propaganda.

When a person studies the history of the Roman Empire, he finds that the Caesar/dictator obtained his position by supposed right of lineage. This was the way with kings. But lineage passed from one to another based mostly on death. So murder was the tool used by these dictators to obtain power. They felt and saw no restraint in murdering their own mother or father or brother. Some were more compassionate and simply sent their siblings into exile.

In order to control a nation of people the ruler must have a propaganda machine in place. So this explains why Kings Charles I and his sons attempted to force their own puppet priests onto the people of Scotland.

When the king is doing evil acts, he certainly doesn't want the priest to be standing in a pulpit pointing out the evil to the listeners. And a "God-called" priest would be obligated by the Holy Spirit and scriptural mandates from God to take a stand against evil. So in order to control a nation, a corrupt and evil king had to control the priesthood. That is the motivation behind King Charles I and his sons as they made their claim that the Crown was the head of the church. It was PEOPLE CONTROL for the purpose of subordinating the masses.

There are writings in the scriptures which state that in the end times there will be an event called the "abomination of desolation." Most Bible scholars agree that this references a man of sin who will be known by the number 666 which is the mark of the beast. This man of sin will enter the "Holy of Holies" to desecrate the inner sanctum of the temple by substituting and representing himself as God. Under the old Jewish law, the Old Covenant/Testament, the priest would accept sacrifices from the people in an outer portion of the temple. Then he would sanctify himself and enter the "Holy of Holies" to present that offering to God. There was a division/veil that separated the temple sections. So based on that precept the general consensus of opinion is that prior to the end of time there will be a man of sin who will be identified by the number "666." This man will initiate the "mark of the beast" so that no one can buy or sell without that mark. At that point in time will occur the event called the "abomination of desolation."
